2. Policies

- a.** Visionary Web Design accounts may be used only by the authorized owners of the accounts, except where specifically authorized by Visionary Web Design. Allowing use of your account by others is prohibited and at your own risk.
- b.** Resale, trade or transfer of any account without express written consent from Visionary Web Design is prohibited. Attempting to obtain access beyond that for which a client is authorized will be grounds for immediate termination of such client's account.
- c.** Attempting to defeat identification procedures, gain passwords or encryption codes, penetrate security measures, circumvent user authentication or use of the Visionary Web Design network to gain unlawful or unauthorized entry to another machine on the Internet; use of a Visionary Web Design account to or attempt to alter or destroy data belonging to Visionary Web Design or another user on any computer
- d.** Many things can happen to prevent access to your web site including, but not limited to Internet traffic, routers not functioning outside our data center, ISP issues, netco provider outages, and DNS issues outside our control. Visionary will not issue credits for these or other types of outages that are beyond our control. All outages will be measured from our location at our data center. If all services are up and accessible to the outside world, regardless of if the client can access their site or email, no credit will be issued.
- e.** Visionary maintains a 99% uptime guarantee. While we backup our servers and data each night Visionary cannot be held liable under these terms for data lost due to acts of nature, fire, flood, server outages, or hardware or software failure. The limit of liability by Visionary Web Design, LLC will be the full amount that the client has paid during the last term of their contract (if paying quarterly or yearly this amount is equal to the full amount paid for that term). Credits will be issued if our uptime falls below 99% as determined by the combined uptime of all services including http, email, ftp, telnet, ssh and mysql.
- f.** By paying your first hosting invoice you are agreeing to these terms and conditions, which are included at our web site and are sent with information for our hosting packages.
- g.** Hosting refunds are offered in the following ways:
 - Monthly hosting is not eligible for refunds.
 - Quarterly hosting is eligible for a refund ONLY if the current term has not started yet.
 - Yearly hosting will be refunded only if more than three months remain on the current term.
